Board members present: Chair Fahey, Supervisors Gundlach and Zweifel and Clerk Christen

**Minutes:** June 2016, **MOTION (MG/RZ)**, all in favor, approved.

**Treasurer report:** June balance-\$360,336.83, Roger asked about Chapman shelter rent being deposited, it was briefly discussed and explained, **MOTION (RZ/MG)**, all in favor.

**Announcements:** Clerk Christen discussed the registration of 17 year old residents prior to elections, it is allowed as long as the resident turns 18 before the election they appear to vote in. Clerk Christen also attended training at the County Treasurer office regarding the new dog licensing program available. At this time the Clerk does not feel the change to a new program is necessary and cannot recommend the need for it.

Chair fahey noted the recent changes in the Fire and EMS director positions, Jeremy Martin took over at July 1<sup>st</sup> as the new EMS Director and Brian Hollis is the new Fire Chief; 772 people were served for the fish boil; charge for calls; Fire is discussing charging up \$500 for calls.

Chair fahey also noted that there is an Open house on Wednesday, July 13 from 1-4 at the new boar production facility being built on County Highway W; the public is welcome to attend to view the facility.

### **Unfinished Business:**

Discussed updates and fee changes will become effective September 1, 2016.

Fee review:

Reserve License: \$10,000 Class B

Cemetery Plot: increased from \$200 to \$400

Driveway: increased from \$500 to \$700 and Park Fee will remain \$300

Cigarette License: increase from \$50 to \$100

**MOTION (MG/RZ)** to approve the increases discussed to be effective September 1, 2016, all in favor, approved.

Building needs: Referendum question to be placed on the ballot for November 2016.

Green County Treasurer tax collection contract: Clerk Christen informed the board there is an increase to a set fee for computer programming charges now of \$250. **MOTION (RZ/ MG)** to approve the contract with the included increase, all in favor, approved.

Assessor Craig Galhouse submitted his resignation to the board per state statutes he complete his contract Exeter August 30, 2016. He will be available for any BOR objections filed with the State.

Clerk Christen has heard from Gardiner Assessing and Associated Appraisal Services regarding estimates for contract of assessment.

Clerk Christen submitted a bid she received from the State Voter site for the cost of obtaining an official list of registrants in the municipality currently. The board instructed her to go ahead and complete the process to obtain the list.
