**Treasurer Report:** Dawn summarizes, balance as of June 30, 2019 is \$465,305.78  
No major road payments yet. Wettach Road repair bill will come in September.

**Supervisor report:** EMS subcommittee meets every two weeks, volunteerism is dwindling only option is to hire staff, cost about \$8.00/person right now, Verona wants \$110.00/person to contract out, volunteers drop off once there is paid staff. Looks like \$80,000 to hire a full time EMS director, raise rates for services. A thank you goes out to Kent. He held a 50/50 raffle during his 4<sup>th</sup> of July celebration that amounted in \$230.00 for a donation to the park. This week John and I will be placing dirt at the park around the big oak tree to cover roots.

Mark – I have nothing new from the Green County Board to report.

Kent – My family rented the shelter for 4<sup>th</sup> of July. It is a great park for an event. Flags were lowered and returned to full staff per the governor's decree. Senior Center meeting will be held on July 11, 2019. The use of round-up is an issue at the cemeteries. It has burned the grass around the headstones.

**Citizen Input:** Does Exeter cover Argue Road? Yes, asphalt over the culvert has been cut, a new culvert will be installed as soon as John can coordinate with patrolman from New Glarus for help. Road will be closed for about 2 hours when they will install new culvert and asphalt.
