**Minutes:** Minutes from September 13, 2021, meeting presented. **Motion to approve September 13, 2021, monthly meeting minutes (KB/TF)**, all in favor, approved.

**Treasurer Report:** Dawn summarizes balance as of September 30, 2021: \$559,315.01. **MOTION to approve report (KB/MG)**, all in favor, approved.

**Announcements:** Monticello Fire contract, all in favor, passed (MG/KB), Population for Exeter, TRIP money – Exeter Crossing Road (east of CC) and EMS New Glarus

**Supervisor report: Ted** – EMS and Fire budgets were passed out, air packs \$200,000, Exeter share for EMS is up about \$15,000.00, recycle asphalt done, one new driveway permit.

Mark – ATV route, Green County and Exeter, one route up CTH D stops at Al's Dayton Place, post at three sites if anyone asks for a new route – Town has final say on town roads.

Kent – last weekend at the garage sale several people came up to talk with Kent. Complaints included litter at the dump. There are two guys at \$10.00/hr., and no one is picking up trash. There were numerous complaints about the sub-par asphalt put in at the dump. How much did we pay for that job? Why is the tractor going back and forth down Hwy 92? What is happening with the old Hideaway? Why is nothing being done? Why is Ted hauling the town skid steer with his personal truck? Ted did reach out to the property manager about the Hideaway – no response

**Committee Reports:** Trash cans with lids for the park? Ricky Kiesling has a knee replacement – send a get-well card. New signs for the park – mount on existing posts.

**Old Business:**

- Fireworks Permit Policy – limit giving permits to July 3,4,5 Motion (KB/MG), all in favor, approved

- Broan out lot question – Ted did call Jim Olson about the out lot. One of his corporations owns all the out lots because the homeowner’s association never stepped up to take over. Jim would be willing to sell the out lots to the homeowners if they want the land and at a fair deal. Jim Olson is currently renting the land to a farmer (pays the taxes). Andrew will talk with the other homeowners and see what they want to do.
- Siggs – broad band, ARPA funding - half has been released the other half will be released in January 2022. Fiber optic cable is \$7,000.00 per mile. Population density is an issue in the rural areas. The companies must have a five-year commitment from the consumer before they would bring the cable to the homes.
