Treasurer Report: Dawn summarizes balance as of May 31, 2024: \$464,375.05. ARPA funds gained \$541.26 in interest. The balance is now \$117,905.65. **Motion to approve treasurer report (MG/KB)**, all in favor, approved.

Supervisor report: Ted – 14 – 17 trees went down on May 21 during the storm. Mark - No, Kent - None. Ted - EMS/Fire meet tomorrow. Belleville wants to reconfigure the board to take over EMS/FIRE. Issued a press release last week and stirred the pot.

Citizen Input: Jenna Jacobson – current 43rd Assembly member and candidate for all of Green County. Ted - asked Assembly member Jacobson why the Milkman Triathalon closes numerous roads when they don't pay taxes?

New Business:

 Liquor/Tobacco/Operator License renewals (Edelweiss Chalet Country Club and Al's Dayton Place LLC) - Motion to approve Liquor/Tobacco/Operator licenses for Al's Dayton Place LLC and Edelweiss Chalet Country Club beginning July 1, 2024 through June 30, **2025**, (MG/KB), all in favor, approved.

- Concrete work around vault toilet at the park Motion to accept bid and add a sonic tube foundation for future light pole, (MG/KB), all in favor, approved.
- Cemetery mowing bids NG does not mow lawns, Montrose has a person mow cemetery road man does not. Mark does not know that John is very busy that we need to hire someone. We need to have a closed session meeting. Brooklyn township has a 2-acre park that road patrolman mows, the rest is done by volunteers. Our park is 11 acres. Motion to put out a notice for bids on each individual cemetery parcel (KB/MG), all in favor, approved.
- One year review of ATV/UTV Ordinance Ted has not had any contacts regarding ATV/UTV usage. More usage since Belleville opened their roads. Randy Main street in Belleville is only 20 miles per hour for ATV/UTV. Black Earth and Cross Plains in Dane County are open to ATV/UTV usage. Dane County would consider opening CTH D and CTH DD. Mark State Hwy 92 will not be opened to ATV/UTV usage between the CTH D's more than 1,000 feet to drive. Randy will talk to Al about letting riders know that State Hwy 92 is not open. Ted motion to keep roads open (MG/KB), approved. Mark law enforcement may not enforce ordinances on township roads. Randy we could contact the DNR, they have more power. Jenne once a new sheriff is in place, they will reach out to see if they will enforce.
